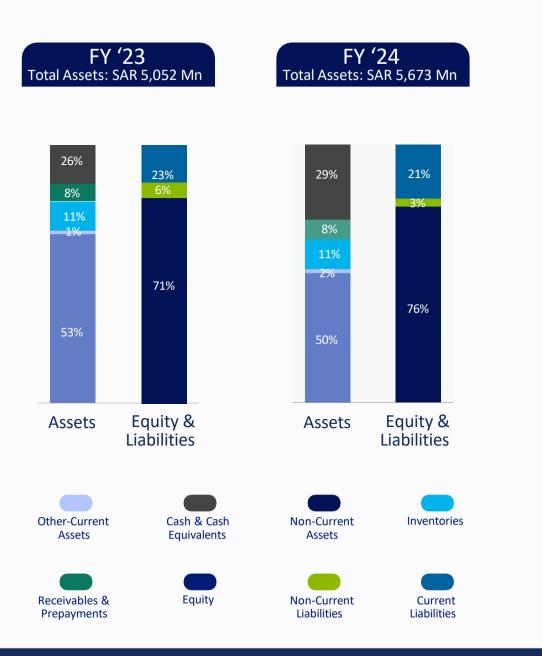
Revenue by Product Category

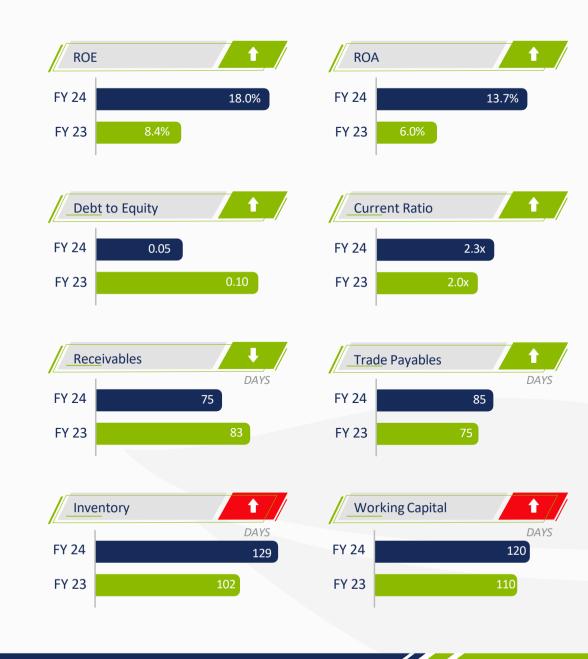


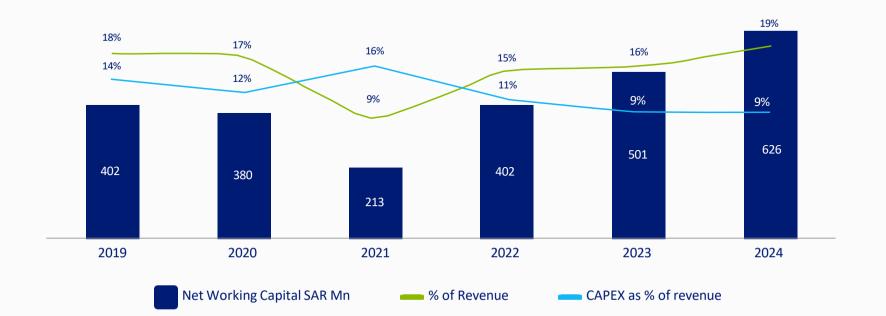
